Selection Porsche GT3 Cup Challenge Benelux Junior Recruit 2018

Based on the two test events mentioned above, the organization of the Porsche GT3 Cup Challenge Benelux will select a winner of the Junior Recruitment Program 2018. The winner will be supported by Porsche GT3 Cup Challenge Benelux and its partners for the 2019 season and will receive a package with a value of 40.000€.

This package includes:

- Participation in the Benelux Junior program 2019 (Physical and mental coaching, media training, Porsche ambassador training, etc..)

Conditions of application for entry and fees

In order to participate in the Porsche GT3 Cup Challenge Benelux Junior Recruitment Program 2018, participants must be younger than 25 years old at the moment of entering the program, must have high level karting experience or first experience in motorsport, without having competed in a Porsche Cup. English language skills are required.

General contractual declarations

With his signature he acknowledges:

To enter the Porsche GT3 Cup Challenge Benelux Junior Recruitment Program 2018 and fairly compete in the coaching program offered to him. To grant the Porsche GT3 Cup Challenge Benelux and her partners the right to use any photo or video material or to actively use the presence of a driver and/or team during an event or coaching day for marketing and promotional purposes.

The driver shall be held wholly responsible for any claims and responsibilities resulting from the entry. The driver shall accept consequences, either for or against him, caused by the character or behaviour of a team member (entrant, driver, mechanic, assistant, guest, etc.), which relate to the agreement with the Porsche GT3 Cup Challenge Benelux organisation, which give reason for damages claim or which is in conflict with the concept or spirit of the Series and/or harmful to its image. A possible such consequence could be exclusion from the Porsche GT3 Cup Challenge Benelux Junior Recruitment Program 2018 for the driver without the right to get any entry fee refunded. Any such decision can be made arbitrarily by the Porsche GT3 Cup Challenge organisation and cannot be appealed against.

Non-liability declarations
